Traditional attribution to Paul—championed by early church fathers like Clement of Alexandria and Origen—has been increasingly challenged by textual, linguistic, and contextual scholars. The epistle's Greek style, rhetorical sophistication, and philosophical underpinnings align more closely with the Hellenized Jewish intellectual milieu of the 1st century, particularly the teachings associated with Antioch's Jewish diaspora. Yet unlike Paul's clear self-identification ("I am a Pharisee... a descendant of Abraham," Heb 11:26), Hebrews offers no biographical signature. The anonymous "Brother Barnabas" (Heb 13:23), often linked to Barnabas of Cyprus, appears only in the closing greeting, further obscuring the identity of the author. Geographically, the epistle was likely composed between 68–70 CE, during the First Jewish-Roman War and the eruption of the Great Revolt. The author speaks from a diasporic perspective—likely Antioch, a major center of Jewish-Christian activity—but addresses a mixed congregation of Jewish believers and

converts navigating dual identities under Roman rule. The geopolitical context is critical: Jerusalem's Temple stood as both spiritual epicenter and symbol of resistance, its impending destruction (completed in 70 CE) casting a shadow over the community's faith in Torah covenant and priestly mediation. Hebrews responds to this rupture by redefining covenant theology around Christ as the "high priest after the order of Melchizedek," shifting focus from ritual sacrifice to a new, eternal mediation. Economic tensions further shaped the epistle's urgency. The early Christian community in Antioch, composed largely of Greek-speaking Jews and freed slaves, faced pressures from both Roman economic exploitation and internal disputes over wealth and exclusion. Hebrews' repeated warnings against neglect (Heb 6:4-6) and warnings against apostasy (Heb 6:4-6)
