Ketubat 11b, part of the Babylonian Talmud’s extensive discussion on marriage contracts (Ketubot 11), addresses the precise articulation of the dowry (ketubah), particularly the phrase “six hundred zuz” (שש מאות זוז), which scholars estimate equated to roughly 30 silver denarii—enough to cover basic needs but also to signal the groom’s commitment. In Jewish tradition, six hundred echoes the six days of creation, framing the marriage as a sacred, ordered act. Economically, it reflects a calculated balance: sufficient to protect the wife from destitution, yet modest enough to avoid reinforcing dependency.
